

For medical students, this book is significantly better than its counterpart, "Big Katzung." This version is more succinct and focuses on the clinically important concepts and drugs. The review questions are also great for assessing knowledge. There are occasionally subjects covered in "Big" Katzung that don't translate to the small version, so keep that in mind, but generally these are low yield. Overall, a better purchase than the big version for most pharmacology needs.

Good questions, but review is not quite as comprehensive as compared to LIR Pharmacology. If you don't have the time for Katzung's Basic and Clinical Pharmacology, LIR is a better bet. I wish that they had simply added the questions to the Basic and Clinical Pharmacology so I wouldn't have to buy this book for them and put out slightly more comprehensive review version with the same questions for those that are time-strapped.

This book provides a quick overview of drug types, which adds context to the drugs being learned. Highly recommend.

This book is OKish. There are things that are great like the questions at the end of each chapter or the tables. Still the editors need to understand the user of the book better. So many times I'm reading a full paragraph that is just a collection of random disconnected facts in no order. They try so hard to condensate all the information. But in that attempt they forget that things need to follow an order they need to have an structure otherwise the person who is studying goes crazy.. There are some great subjects where everything's is given in a good order that makes plenty of sense giving you proper explanations of why things happen in a certain way. The subjects on cardiopharmacology are all of them great. Still other subjects are absolute crap almost worthless. It feels like a computer algorithm wrote the whole antibiotic section. I understand things are hard sometimes but it's not ok to make it harder. The best example is the antiviral section. you have a collection of more than 40 antiviral drugs one after the other. Each one of the drugs has a list of minimum 8 side effects. No effort to help you understand which are the clinical relevant ones, no effort in explaining the ones that have physiological sense. I can't randomly learn around 500 side effects in a random order and I have a pretty good memory plus it's just a torture to go through this stuff. I understand the side effects need to be there but Please understand that things need to be digestible. If I want random facts one after the other I don't pay a book with professional writers and editors. I guess there is not a better book out there but let's be clear this book is not as great as they say.
